Concerns stated about aggressive police attitude towards neighbors congregating outside on Park Street. Businesses have complained about loitering affecting their businesses. **Neighborhood Investment Guidelines:** Melvyn presented guidelines for IRS administrated Opportunity Zones. These are tax shelters for wealthy individuals to invest in urban areas. Funds must be created by December 31<sup>st</sup> with a 10-year benefit to investors. There are no provisions in the legislation for how money is invested regarding community needs, affordability, etc. These guidelines, adopted already by SINA, are an attempt to get ahead of the curve in having community impact on any potential projects. There are currently no projects/investments identified but the possibility is there. Discussion about residents never being listened to and having little impact over many years of advocating. High end developments might lead to dislocation of residents and increased rents. On other hand, might be tool to bring capital into neighborhood. Group decided to put off vote until next NRZ meeting to give time to research further. Sean Fitzpatrick will send Aaron a 3-page piece on Zones.

**Trinity College Neighborhood Survey:** Megan Brown of Liberal Arts Action Lab reported on door to door survey occurring this summer. Purpose is for Trinity to better understand how to be a good neighbor. Last survey was done in 2001. Are there some questions we would like included? Results will be shared this fall. Suggestion to use Youth Service Corps members to supplement students and 7 community interviewers. Members made suggestions for questions to Megan.
